SUMMARY:

Under general supervision, performs prescribed radiologic and/or CT procedures requiring specialized knowledge and skill in support of the provision of diagnostic and/or therapeutic services to a specific patient population. May prepare and administer various chemical mixtures as appropriate to the nature of the procedures being carried out.

ESSENTIAL FUNCTIONS

- Prepares facilities in accordance with procedural requirements; calibrates equipment, and prepares
 medicine and materials as required; cleans and disinfects equipment in accordance with sterile
 procedures and standards.
- Prepares patient for radiographic or CT Scan procedures as appropriate to requirements; explains
 procedures to patients and positions patients as appropriate to prescribed procedure; assists
 patients at end of procedure.
- Determines appropriate methodology and techniques to use in administering procedures; calibrates and adjusts equipment as appropriate; arranges immobilization and/or support devices for proper patient positioning; adjusts shields; selects appropriate film or film printing device.
- Follows prescribed procedure in the administration of radiography or CT scans; determines appropriate calibrations and/or techniques, arranges immobilization and/or support devices, and selects appropriate film or film printing device.
- Develops or prints film as appropriate, in accordance with proper photographic techniques.
- Performs general office duties such as delivering and retrieving film, burning CD's and scheduling patients.
- May take mobile unit to patient's room or emergency room to perform procedures, as appropriate
 to the operational context of the specific position.
- Ensures proper care in the use and maintenance of equipment and supplies; promotes continuous improvement of workplace safety and environmental practices.
- Utilize C-Arm in surgical settings while adhering to sterile precautions and sterile field management under stressful environment and in a timely manner.

 Other duties, responsibilities and activities may change or be assigned at any time with or without notice.

- Adhere to dress code, appearance is neat and clean.
- Complete annual education requirements.
- Maintain patient confidentiality at all times.
- Report to work on time and as scheduled.

- Computer literacy, including but not limited to, data entry, retrieval, and report generation.
- Must not have any restrictions for physical work for which reasonable accommodation cannot be made.

- Graduate of accredited school and registered with the American Registry of Radiologic Technology (ARRT).
- Must maintain a license with the Texas Medical Board as a general radiographer.
- One (1) year of current experience preferred.
- Must have and maintain CPR certification.

- Standing for extended periods of time.
- Standing, walking and reaching.
