Motion made by Lori McBrayer to engage the Skiles Group as the construction manager to design, prepare, and Seek competitive bids for a future Medical Office building to be constructed on Lot 2E in Chisholm Trail. The funding for project construction is yet to be determined, seconded by Mark Maples. Motion carried unanimously.

Recognizing the medical need for expansion of Emergency services to the underserved community of Bowie, Texas and, realizing the positive financial feasibility to Jack County Hospital District, we move to support the extension of the FCHS emergency and outpatient departments to the city of Bowie and lease the former Bowie hospital building for this purpose.
